AFTER ATTENDING A TRAINING SESSION, VOLUNTEERS OF ALL AGES WORKED WITH OUR STUDENTS ONE HOUR EACH WEEK, DEVELOPING THEIR LITERACY SKILLS BY MAKING READING AND WRITING FUN AND INTERESTING. THE PROJECT READS TUTORING HOUR STARTED WITH A READ-ALoud STORY SESSION, SMALL HEALTHY SNACK, AND A Q AND A FOLLOW-UP TIME.
